

# **Website Terms and Conditions of Use | NMK Electronics Trading LLC – Sole Proprietorship (UAE) (Part of the Midwich Group)**

## **1. Introduction**

These Terms and Conditions ("Terms") govern the use of the NMK Electronics Trading LLC – Sole Proprietorship ("NMK", "we", "our", "us") website and related services. By accessing or using this website, you confirm that you are a commercial entity operating within the United Arab Emirates (UAE) and agree to comply with these Terms and all applicable UAE laws.

## **2. Definitions**

Administrator – A representative appointed by the Buyer to manage access rights.

Buyer – A registered commercial customer purchasing goods from NMK.

User – Any individual authorized by the Buyer to access or use the website.

Goods – Products and services made available for purchase.

Terms and Conditions of Supply – Conditions governing the sale of Goods.

## **3. Eligibility & Business Use Only**

Only commercial entities may register. Users affirm authority to legally bind their organization.

## **4. Transparency, Regulatory Disclosures & Compliance**

Information provided must be clear and accurate in accordance with UAE Federal Consumer Protection and Digital Trading regulations.

## **5. Data Protection & Privacy (UAE PDPL)**

Personal data is processed in line with UAE Federal Decree-Law No. 45 of 2021 on Personal Data Protection. Users must provide accurate details and consent where required.

## **6. Acceptable Use & Cybersecurity**

Users may not attempt unauthorized access, system probing, malware distribution, service interference, or false data transmission, consistent with UAE Cybercrime Law.

## **7. Access, Security, and Login Credentials**

Administrators shall maintain accurate business information and manage access rights.

Users must ensure secure use of login credentials.

## **8. Intellectual Property Rights**

All website content belongs to NMK or its licensors and is protected under UAE IP and copyright regulations.

## **9. Website Availability, Modifications & Service Changes**

NMK may update, modify, restrict, or suspend website services without notice in accordance with business and regulatory requirements.

## **10. User Content & Submissions**

Users grant NMK a global license to use submitted content.

## **11. No Warranties**

Website is provided "as is" under UAE law.

## **12. Limitation of Liability**

To the extent permitted by UAE law, NMK disclaims liability for service interruptions, data loss, indirect damage, or errors arising from website use

Users shall indemnify NMK against losses resulting from violations of these Terms, misuse of the website, or regulatory breaches
